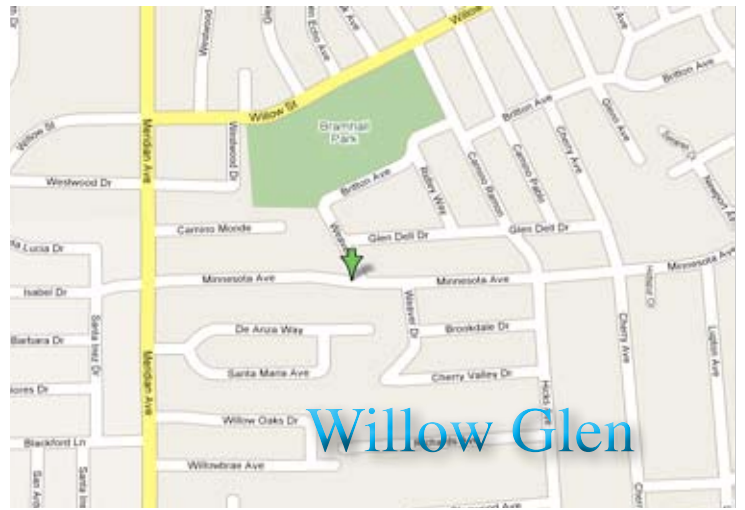
Membership Dues
