## President's Message

### **Dredgings From The Pond**

**HAPPY EASTER!** What a wonderful time of year. We haven't had to heat or cool our home for the last six weeks or so. And as you might have guessed, our pond temperatures are benefiting from this warm early spring. My front pond is currently 65 degrees, well within the range to be feeding the fish. I actually started feeding them a few weeks ago. The water temps climbed into the high 50's and the fish were coming up to the surface, mouthing to me, as if to say, "Hey, how about some food down here!"

I was feeding them a winter, low protein mix, once or twice a week. After about a week, I noticed one of the fish had a redness on its side, and each day it grew larger. Sunset Koi provided me with some Proform C and medicated koi food. Since it was the first time for me to use Proform C, I followed the directions carefully. With the medicated food, I saw immediate improvement. It has now been 14 days. The water is crystal clear again and the fish looks great. Tomorrow will finish the two-week treatment of medicated food.

This time of year can present hazards; our fish are beginning to eat, but their immune systems are not fully engaged. This leaves them vulnerable to parasites and bacteria that are flourishing in the warmer water temperatures. Be on the lookout for problems and be ready to react quickly before things get out of hand.

My back pond, because of additional heating, is in the low to mid 70's, so their immune systems are in full gear. The water is beautifully clear, showing off a healthy coat of algae growing on the sides of the pond. When they talk about "living water," this is it. High turnover rates, good circulation, plenty of aeration and lots of filtration lead to healthy living water. The ecosystem is in balance with beneficial biological reactions occurring throughout the pond. The fish are being fed 8-10 times per day and their growing period will extend until the end of September.

I have a renewed appreciation of what goes into achieving healthy koi due to the "Koi Health Advisor" class being offered by AKCA. If any of you are interested in taking this class, contact Julie Miller. Her e-mail address is jam1150@hotmail.com.

are needed:

GENETICS: The most important aspect of a koi's growth potential.

<u>WATER QUALITY</u>: In a pond of 10,000 gallons a 1x per hour turnover would be optimal and can also be achieved in a 5000 gallon pond by turning the water over 2x per hour. Adding water in a small trickle keeps the water fresh and

keeping the bottom free of debris is essential.

NUTRITION: Always feed fresh food. John also feeds his fish tofu and sweet

potato for variety.

<u>DEFINITIONS:</u>
Tosai, a koi in its first year, o to 1 year old.

Nisai: a koi in its second year, 1 to 2 years old. Sansai, a koi in its third year, 2 to 3 years old Yonsai, a koi in its fourth year, 3 to 4 years old

Jumbo Tosai: a few select koi that have been raised in warm water and fed all

winter to achieve their maximum growth potential in their first year.

ADJOURN: John ended the meeting by showing videos of this year's ZNA koi show.

Dear Club Members,

I love reading happy articles about koi and ponds, shows and tours. Every single aspect of our hobby involves water. The old saying "healthy water equals healthy koi" keeps us on our toes to achieve this goal.

Here comes the unhappy part. Californians are facing another dry hot summer and Redding is especially hot as everyone knows. We for over a year in my water district.

I started out to write an article about water rationing and how fact, these companies are still taking it effects our hobby. To that end, I've the drought conditions in California and how our government officials are looking at dealing with the situation.

You may have read that Gov. Brown has signed a \$1 Billion Emergency Drought Package to address infrastructure issues, greenhouse gas emissions, irrigation and pumping systems, groundwater management and expansion of water use efficiency and conservation.

This is a complicated and far reaching endeavor. You can read the bill on Gov. Brown's website. Because of the amount of money being allocated, I'm hopeful the money will be well-spent and not vaporize like the snow pack in the mountains. Fingers crossed here.

I read another article about private bottled-water companies which have been granted access to have been under water-use restrictions springs in California's national forests. This has been going on since the 1980's with.."not a lot being done to regulate the amount of water being taken. In water for their profit with little or no been reading article after article about public awareness" even in the face of a historic four-year drought.

It reads in part: "The US Forest Service has been allowing Nestle Waters North America to keep using a pipeline to transport spring water out of the San Bernadino National Forest even though it's permit expired in 1988." Please read the entire article at ian.james@desertsun.com.

Closer to home, Crystal Geyser Alpine Spring Water is right here in the Shasta Trinitu National Forest. According to their website, their plant near Weed, Ca. "services the west coast as well as export to Japan." This begs the question: How much water is being exported? I don't mean as relief after Japan's horrendous tsunami but as a year-in, year-out practice in light of drought conditions in Calif.

Crystal Geyser's facility on Olancha Peak in the Sierra Nevada mountains "began production in 1990. again. Since then two more plants have been built in Olancha to meet demand." Crystal Geyser is a national brand with plants in several other states. So, where is all of this water going?

I know I'm sounding like an activist at this point. I'm actually a and would really like to keep it going. surprised citizen. I'm quilty. I have purchased the very brands mentioned, Thanks for listening. but I won't be buying bottled water in Renee Ottsman the future.

Here's the thing, we are about to spend a BILLION dollars for water conservation, ground water management, etc., while the Forest Service has been turning a blind eye to an egregious water sell off.

One sentence from the Sun Desert article:

"The Forest Service has allowed the company (Nestle) to keep using the expired permit while charging an annual permit fee of \$524." There is no reporting on the amount of water this fee has "purchased." Do the math. This means HUGE profits for Nestle. The water is virtually FREE! This boggles my mind. Does it boggle yours?

According to the Forest Service, they are working on a backlog of 360 expired permits, which means this is only the tip of the iceberg. I say put a cork in that pipeline people. I will never look at bottled-water on the shelf in my grocery store the same way



Each spring over a thousand of the best young koi from breeders all over Japan vie for the title of Grand Champion.

There are several sizes of fish to be considered, but the largest is 63 bu (24.8"). My koi competed in the 58 bu (22.8") category. It didn't win the Best-In-Size, but did receive a "Junyusho" (runner up) award. As usual, everything is different in Japan.
