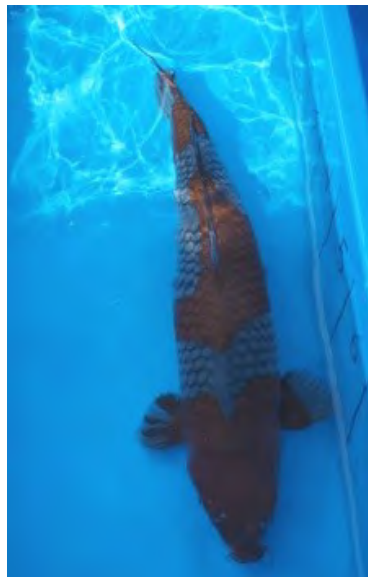

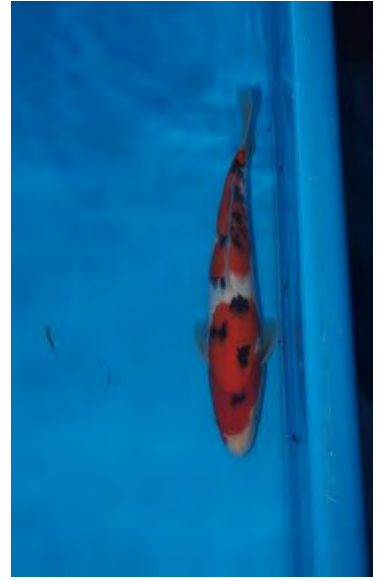

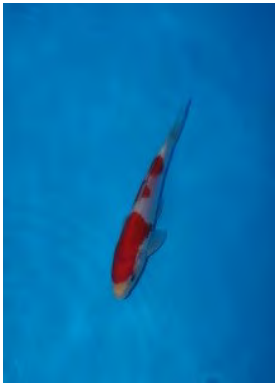

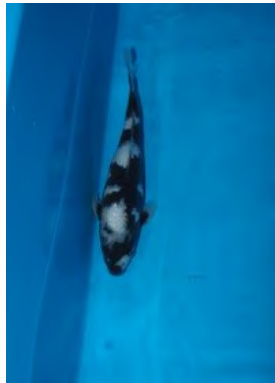

Menware (men-wa-re): Black lightening bolt across face of Showa



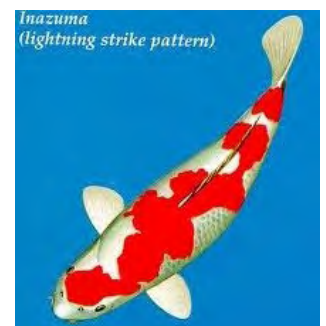
Moto guru (mo-to gu-ru): Black pattern at base of pectoral fins on Showa, Utsuri, or Hikari Utsuri



Kuchi Beni (ku-chi beni): Red on lips like lipstick on koi



Inazuma (in-a-zu-ma): Lightning red pattern on Gosanke (Kohaku, Showa or Sanke)



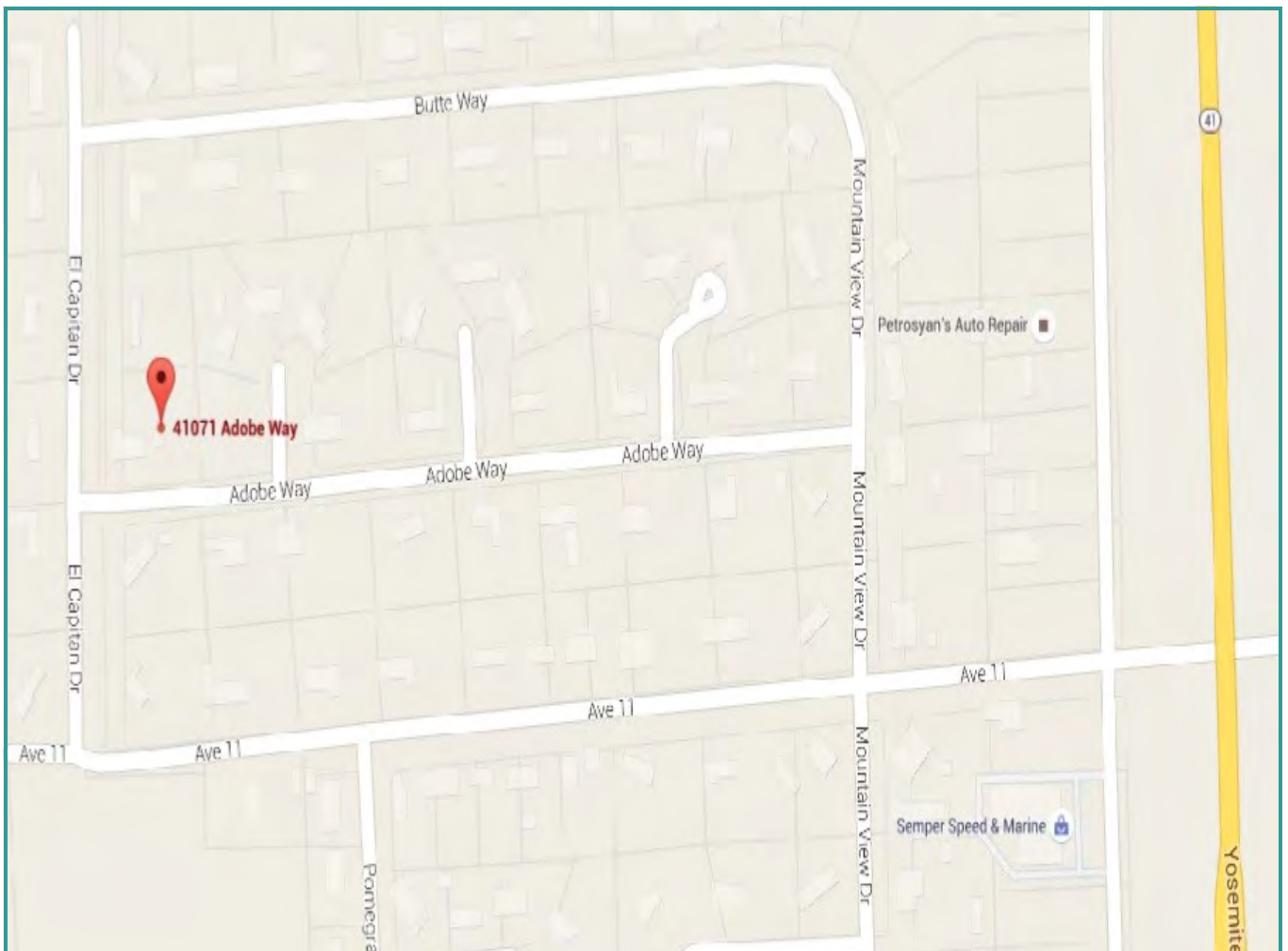

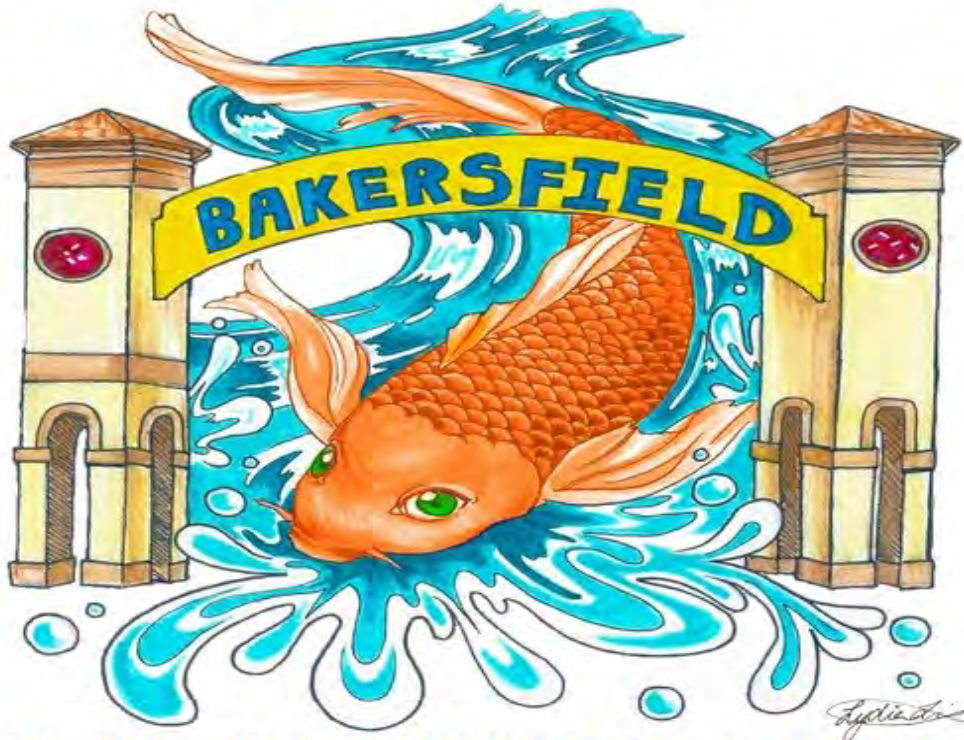
